The e-APP for Europe is a transnational e-justice/e-administration project designed to develop best practices in relation to the Apostille Convention by promoting the e-APP, in particular the use of e-Registers of Apostilles. This is a joint initiative of the Permanent Bureau of the Hague Conference on Private International Law and the Ministry of Justice of Spain in association with the Ministries of Justice of Finland, France and the Czech Republic. The 18-month project is funded by the European Commission under its "Civil Justice" programme. The project is comprised of three interrelated elements: 1) the 6th International Forum on the e-APP (which took place on 29 and 30 June 2010); 2) development and implementation of an e-APP system in Spain; and 3) the holding of three regional meetings across Europe (in Helsinki, Prague, and Paris) to encourage all participating States to implement the e-APP, in particular e-Registers.
