The e-APP for Europe is a transnational e-justice/e-administration project designed to develop best practices in relation to the Apostille Convention by promoting the e-APP, in particular the use of e-Registers of Apostilles. This is a joint initiative of the Hague Conference and the Ministry of Justice of Spain in association with Finland, France and the Czech Republic, which is being funded by the European Commission under its "Civil Justice" programme. The 18-month project is comprised of three interrelated elements: 1) The development and implementation of a central e-Register of Apostilles for all Competent Authorities in Spain; 2) The holding of three regional meetings across Europe to encourage all participating States to implement e-Registers; 3) The holding of the 6th International Forum on the e-APP (which took place on 29 and 30 June 2010).
