# Benefits

- Concept of an electronic "register" echoed in the MERS eRegistry, State Departments of Motor Vehicles, etc.
- An e-Register provides an effective means to verify the fact that a certification occurred
  - Increase the speed by which authentications can be validated or verified by relying parties
  - Provide a more secure and stable audit trail of authentications performed
  - Increase trust through "transparency"
  - Help citizens/corporations transact business more efficiently
- > The problem is not the technology...



  - Criminal defense!


# Notary Register Requirements

**Total:** 47 states, territories and jurisdictions




# Archival and Disposition

\* AK, AR, MN, NH, NJ, and WI do <u>not</u> require journal, but require disposition of records.





- Minnesota we are hopeful for implementation early next year


